**ORDER GRANTING JOINT MOTION FOR AN EXTENSION OF TIME FOR SECOND ROUND DISTRIBUTION OF SETTLEMENT PAYMENTS AND TO SUBMIT FINAL LIST OF CLASS MEMBERS AND AUTHORIZATION TO USE RESERVE FUNDS TO COMPENSATE AN INVESTIGATOR**

This matter is before the court pursuant to the joint unopposed motion for an extension of time for second round distribution of settlement payments, to submit final list of class members and authorization to use reserve funds to compensate an investigator.

GOOD CAUSE APPEARING, the motion is granted. The time for the Settlement Administrator to distribute funds remaining in the Net Settlement Fund and Reserve Fund to eligible class members in the above-referenced cases who cashed their first-round settlement

payments is extended to **April 30, 2018** and the date by which FedEx Ground shall submit additional class members eligible for Reserve Fund claims to the Court shall be **March 16, 2018**. Additionally, the Co-Lead counsel are authorized to pay reasonable compensation to an investigator of their choice to assist in locating missing class members from the Reserve Funds established in the applicable constituent case.
